At West Seattle Thriftway, we are proud to be able to give a little something back to our community with our 1% Cash Back for the Community program. It's our way of saying thanks to you, our valued customers.

West Seattle Thriftway will refund 1% of all purchases to your charity or non-profit organization.

The program is simple. Your church, youth group, social service organization, fraternal school group or school can fill out an application with the store management.

Get your family and friends involved too! Whenever they shop at West Seattle Thriftway have them save their receipts and turn them in for 1% cash back. That's all there is to it.

The 1% Cash Back for the Community program is a great way to raise needed funds, just by shopping at Thriftway!



If you decide to participate in West Seattle Thriftway's 1% Cash Back Community Fund raising Program there are a few simple procedures we ask that you follow in order to receive your funds as quickly as possible.

#### INSTRUCTIONS:

1. Cash register receipts must be from West Seattle Thriftway.
2. Cash register receipts must be for purchases made after the date your organization enrolled in the program.
3. Attach the receipt and adding machine tape denoting the sum of each bundle of receipts, secure with a large paper clip or rubber band and enclose receipts in a manila envelope that is taped or stapled shut. We reserve the right to reject receipts that are unkempt and not totalled to our specifications.
4. Receipts for money orders of gift cards/certificates will not be accepted.
5. Purchases of both taxable and non-taxable items are available for refund, however, do not include sales tax or liter tax (which appears in the body of the receipt) in your total. Tax cannot be refunded.
6. Please submit your group's receipts to West Seattle Thriftway's Customer Service Desk, payments are made quarterly during the year.

A check will be issued to your organization for the amount of one percent (1%) of your total receipts.
